To begin with, the Act Improving the Fight Against Trafficking in Human Beings came into force in October, implementing at last the EU Directive on Preventing and Combating Trafficking in Human Beings and Protecting its Victims. KOK was closely involved in the entire legislative process and we are looking forward to seeing the practical impact of the reform to the statutory constituents of trafficking in human beings and exploitation.

Stakeholders on the ground will face great challenges dealing with the other forms of exploitation that are now considered criminal offences.

Moreover this year's reform to the legislation on sex offences finally brought about a paradigm shift, moving towards an approach for which women's rights organisations have campaigned for years – »No means No«.

A further development that will be keeping us busy in the future is the Protection of Prostitutes Act announced by the German Federal Law Gazette [Bundesgesetzblatt] at the end of October. In 2016, KOK also continued working on »Flight and trafficking in human beings« through a dedicated project. KOK also supported various projects and measures initiated by specialised counselling centres regarding the topics of trafficking in human beings and displacement.

We would like to express our warmest thanks to all our advocates and cooperation partners. In addition, we would like to say a special thank you to the staff of our member organisations for the work they do every single day on the ground and for their enduring, strong commitment despite the sometimes challenging conditions.

This is, after all, precisely the work that contributes to improving the situation for persons facing trafficking and exploitation.
