

# Trafficking in Human Beings, Exploitation and Violence Against Migrant Women

More and more people across the world are migrating to seek work. By doing this, they sometimes face structural, as well as psychological and physical violence. Migrants often have an insecure legal and social status and are under pressure to secure their livelihoods and that of their families which is why they are often exploited. Gender hierarchies and violence against women frequently play a key role in cases of trafficking in human beings for sexual exploitation, as well as in other fields. Migrants, as well as German citizens, can be affected by trafficking in human beings.

Trafficking in human beings constitutes a serious human rights violation. It can take various forms and occurs in different areas:

- Sexual exploitation
- Exploitative employment relationships
- Exploitation in marriage
- Forced begging
- Exploitation of criminal activities
- Removal of organs

Root causes for trafficking include increasing poverty in the countries of origin, as well as the restrictive migration policies in the target countries. This is reinforced by the fact that perpetrators run very little risk of being held accountable for their criminal offences while potentially making high profits. Human trafficking and exploitation are listed as criminal offences against personal freedom under Article 232 et seq. of the German Criminal Code.



**KOK** is the only organisation in Germany bringing together 38 specialised counselling centres and further organisations that address the issue of trafficking in human beings, exploitation and violence against migrant women at the national level.

**KOK** works with an intersectional approach, i.e. with the knowledge that there are many different forms of discrimination that converge and can reinforce each other.

**KOK's** work focuses on representing the interests of women and, more specifically, migrant women. Moreover, thanks to its experience, **KOK** provides expertise on all groups of trafficked persons.
